From Toronto, Oakville, Burlington (Central Campus)

- 1. Travel westbound on the QEW or Highway 407
- 2. In Burlington, take Highway 403 to downtown Hamilton
- 3. Exit Highway 403 at the Main Street West off ramp
- 4. At the traffic signal turn left on to Main Street West
- 5. Turn immediately right on Newton Avenue. As this street crosses King Street it becomes Sterling Street. Proceed up Sterling Street onto the McMaster campus.




